**BURNING REGULATIONS**

**§ 92.40 BURNING MATERIAL IN STREETS RESTRICTED.**

No person shall make or kindle any fire in any of the streets, lanes, avenues, alleys, public square, or grounds of the village.

**§ 92.41 ACCUMULATION OF WASTE AND DEBRIS PROHIBITED.**

No leaves, grass clippings, trees or other plant growth materials shall be deposited or piled on any streets, public easements or right-of-ways of any streets so as to cause the accumulation of such matter that may lead to the blockage of any public storm drain or outlets.

**§ 92.42 BURNING OF GARBAGE PROHIBITED.**

No garbage shall be burned in any metal container or incinerator in the village.

**§ 92.43 BURNING OF LEAVES AND OTHER YARD WASTE.**

(A) Except as provided in division (B), the terms and provisions of §§ 92.40 through 92.45 shall not

apply to the burning of leaves in the village, except that no fires shall be lighted or kindled for the purpose of burning leaves between the hours of sunset and sunrise.

(B) The burning of leaves, grass and brush is prohibited within the village limits between March 1 and October 31 of each year.

(C) The burning of any rubbish, leaves, hay, grass, brush, or other materials outside the village limits is prohibited so long as the smoke from such fire emanates into the village limits.

(D) Nothing in this section shall be deemed to prohibit the village, its agents or employees, from burning any leaves, hay, grass, brush, or other materials in order to clean, repair or maintain drainage ditches in the village, or to dispose of organic materials.

**§ 92.44 FIRE CHIEF TO DIRECT OPERATIONS AT FIRES.**

The Fire Chief of the Coal City Fire Protection District shall have sole control of the police, as well as all persons present, when at fires and may appoint persons to assist in protecting property in such manner as he or she may deem necessary. The Village Board shall pay persons a reasonable compensation for services so rendered when recommended by the Fire Chief.

**§ 92.45 POWER OF ARREST FOR FIRE VIOLATIONS.**

For the purpose of the better enforcement of §§ 92.40 through 92.45, the Fire Chief or Assistant Fire Chief is empowered to arrest or cause to be arrested, with or without process, all persons who
